- To Receive Apologies and Approve Reasons for Absence.** A-M Collins L Dilkes M Brasset (Holiday) Cllr P Bignell SNC Cllr A Brown - NCC **Resolved** Council accepted apologies.
- To Invite Declarations of Interest.** None.
- Register Of Interests Update.** None.
- Public Participation.** Mr Wright expressed concerns about work on trees in the cemetery. NH said this was in hand. Also concerned about state of village sign. CK would check an arrange for a clean up. Mrs Spokes was upset that the swings had been damaged by adults using them and was concerned that they be usable again by the start of the summer holiday . She wondered whether unused allotment plots could be utilise for solar power; an whether the phone box could become a library. It was explaine that it was still a working phone box. CK thanked her cleaning it. She also expressed concerns about the Green being used for parking spaces.
Bill Corner was disgusted with the state of the allotments, and felt that regulations were not being adhered to or enforced.
Cllr DH reported that the Local Plan was due soon, an thought it might be useful for the Neighbourhood Plan group to meet with SNC planners to discuss differences.
- To confirm and sign minutes of the meeting held on 5th June 2017. Resolved.** Minutes were accepted as a true record. Chairman duly signed minutes and agenda.
- MATTERS ARISING FROM THE MINUTES; None.**
- REPORTS**
 - Lighting.** Lights 102 opposite shop reported out. Aylesbury Mains had chosen a suitable location for a light column, but it was still necessary to check the costs of installation if that was accepted. Not all residents were in favour.
 - Roads and pavements.** Felt to be in very poor condition, work would soon take place on Middle St. It was still rumoured that Heyford lane would be patched rather than resurfaced in July. A speed sensor had been Furnace Lane prior to a speed survey taking place.
 - The Green and Play Area.** Repairing the swings was proving more difficult than anticipated as the top bars were damaged and getting replacements was awkward as they were American manufacture an Imperial size, and difficult to source now. It was felt that the swings should be repaired or replace as a matter of urgency.
Stowe tree services to be asked to remove dangerous limb on Robinia tree on Coronation Row.
Mr Stanford to be asked to trim an Ash on the Green opposite the Memorial Green.
 - Playing Fields.** There had been complaints about the hedge on the entrance road, and this has now been cut.
 - Trees. Resolved.** To remove dangerous branch from Robinia in Coronation Row.
Resolved. To semi pollard 2 diseased Limes asap. Stowe Tree Services to proceed. Quote for £500 to pollard later in the year.
Mr Stanford to be asked to trim Ash on the Green overlooking the Memorial Green.
 - Allotments.** Concerns expressed regarding the general state of the allotments and paths in the area of the unused allotments. Working party to be forme to look at improving the general state of paths, etc.
 - Footpaths.** Footpath KS2 Manor Park to river bridge reported to Streetdoctor, would be cut in due course.
 - Churchyard.** The PCC had receive quotes for repairing the North wall in the region of £6000. PCC to apply to Council for a grant towards this work .
Resolved. Diseased Lime in Churchyard to be removed and others trimmed of epicormic growth at a cost of £455. Stowe Tree services to proceed as this is below threshold for 3 quotations to be needed.
 - Joint Burial Board.** Various works on trees were reported to be in hand.
 - Youth Club.** NHB money had been granted towards new fence.
